

## PA Reactivation of License That Has Been Inactive or Expired For More Than Five Years

1. Obtain a Certificate of Exam Eligibility. Complete the form: 'Reactivation of Standard License That Has Been Inactive or Expired for More than Five Years' (found on page 2) and submit it to the PA Real Estate Commission.
2. Apply to take the exam with PSI: Enclose the Certificate received from Pennsylvania Real Estate Commission and your payment of \$54.00.

3. Pass both portions of the PA exam.

## REACTIVATION OF STANDARD LICENSE THAT HAS BEEN INACTIVE OR EXPIRED FOR MORE THAN FIVE YEARS

Under Section 501 of the Real Estate Licensing and Registration Act, a license may only remain inactive for a five-year period from the date the license expired or was placed on inactive status, **whichever is sooner**. After the five-year period, a license may only be reactivated once the licensee passes both portions of the real estate examination.

In order to retake the examinations, you must receive a Certificate of Exam Eligibility from the Commission. To obtain this Certificate, complete the request form below, and return it to our office.

Your request may be mailed, faxed, or emailed.
